## SECTION 4: First aid measures

### 4.1 Description of first aid measures

#### General information

Remove contaminated clothing and shoes immediately, and launder thoroughly before reusing. Most of the hazards come from the molten, hot product.

## SECTION 7: Handling and storage

### 7.1 Precautions for safe handling

#### Advice on safe handling

Risks inherent to handling the product must be minimised by applying the appropriate protective and preventive measures.
